## I.) ROLL CALL

# II.) APPROVAL OF CONSENT AGENDA

# **III.) PUBLIC COMMENT**

Dan Schlueter and Donna Cimino were present to address the board again regarding his building situation at W First. Dan began by stating that the village website states that no permit is needed for window or siding. This is correct. He then stated that he had been lied to for six months. When asked by who, he stated the mayor and Lori. President Hackney directed the attorney the file the lawsuit and schedule a new court date.

Bill Chuich requested that village look at the tree in front of his house. Bark and limbs are dropping off. PWS Robertson will have Zehr's come out and look at it.

C. **Police Chief** – Village President Hackney informed the board that Chief Lewis had called him and requested that the police department be included in the wage increases.

It was clarified that, yes, the village code does not require a building permit to replace windows or siding on existing buildings. Mr. Schlueter's building is new and incomplete construction.

Trustee Smith moved, and Trustee McGahan seconded the motion to approve the Class "C" and Class "D" liquor license for Fuller's Smokehouse Bar & Grill for a term of one year beginning on May 1, 2024, and expiring on April 30, 2025, contingent upon receipt of the health department certificate.

Trustee Rossman moved, and Trustee Smith seconded the motion to approve the replacement of the park bathroom doors at a cost of \$8,262 by Schieler Quality Builders.

Trustee McGahan moved, and Trustee Lee Berardi seconded the motion to adopt Ordinance 695, setting the new rates for water and sewer, effective May 1, 2024.

Trustee Rossman moved, and Trustee Kraemer seconded the motion to approve the 5% increase in wages for all village employees effective with the first pay period after May 1, 2024. This increase does not include the trustees, president, or clerk.

Trustee Hackney moved, and Trustee McGahan seconded the motion to approve and authorize the village president to sign the intergovernmental agreement with Tazewell County Health Department for the recycling grant in the amount of \$2,020.35.

Ayes: 6 – Hackney, Kraemer, Lee Berardi, McGahan, Rossman, Smith Nays: 0 – None There being six affirmative votes...Motion Carried Trustee Rossman moved, and Trustee Hackney seconded the motion to approve the annual schedule of meeting dates as presented.

Trustee McGahan asked if the lead service form needed to be mailed out to those people who received their newsletter via email. The requests that went out in the newsletter are just one tool the village is using to gather the needed information. They are not necessary to satisfy the reporting requirements.

Trustee Lee Berardi noted that the board needs to consider succession planning regarding board replacements as needed.
